**Minimum Education and Experience:** High school diploma or GED: supplemented by two (2) months experience and training preparing and/or serving food; or an equivalent combination of education, training and experience. **Special Requirements:** Must be able to work with inmates.

**Conditions of Employment:** Each applicant tendered an offer for employment with the Cumberland County Sheriff's Office will be tested for the use of drugs specified in the county policy. A thorough background check will be conducted and if selected, employee must submit fingerprints. **No criminal convictions.**

**General Position Description and Duties:** Performs preparatory work and cooks food in accordance with recipe directions; serves meals to inmates. Must be able to use meat slicers, industrial kitchen utensils and other food preparation equipment. Must maintain proper food handling, and adherence to sanitation procedures. Cleans and maintains the kitchen, storage areas, ovens and dining room; washes dishes and industrial kitchen equipment. Prepares special diet trays. *Performs related work as required.*

**Knowledge, Skills & Abilities:** Has working knowledge of principles and practices of preparing, cooking and serving food. Has working knowledge of the laws, ordinances, standards, and regulations pertaining to the essential duties and responsibilities of the position. Clearly understands the occupational hazards and safety precautions required to perform the essential functions of the work. Has working knowledge of terminology and related professional languages used within the department as such pertains to work responsibilities. Knows how to maintain cooperative and effective relationships with intra- and interdepartmental personnel, as well as any external entities with whom position interacts.
