## Surplus FAQ – Frequently Asked Questions

- # How much are the properties?
  - **The tax lien amount is the purchase price for each of the properties shown**
- # Can they be purchased for a lower price?
  - **NO. Purchase offers cannot be lower than the tax lien amount**
- # Can I get my money back?
  - **LESS THE COST OF ADVERTISING – Your bid deposit can be refunded – LESS THE COST OF ADVERTISING**
- # How do you buy these?
  - **Anyone interested would place an initial Five Percent (5%) bid deposit based on the lien amount to start the bid process**
  - **NOTE: IF the lien amount is LESS THAN \$1,000 bid deposit will need to be the ENTIRE lien amount to start the bid process**
- # How often is this list updated?
  - **There is not a specific time frame for updates. It is only when needed**
- # Are these houses, which ones have houses; is this a list of houses?
  - **NO. Properties may or may not have a structure. NO this is not a list of houses**
- # Are the tax values correct?
  - **The values are from the CC Tax Dept. 2009 Tax Revaluation**
- # Who can tell me about these if they have any other liens, how can I find out and can you refer me to an attorney?

- # Will the purchase price go any higher?
  - **YES. The purchase amount will be higher if a counter purchase offer is received**
- # If MY bid is upset do I have to bid again?
  - **NO. You can opt out and when the 10 day deadline is closed, our office will submit a refund request for your surplus bid deposit**
- # Are there any other fees or costs?
  - **Register of Deeds Recording Fee is \$26**
