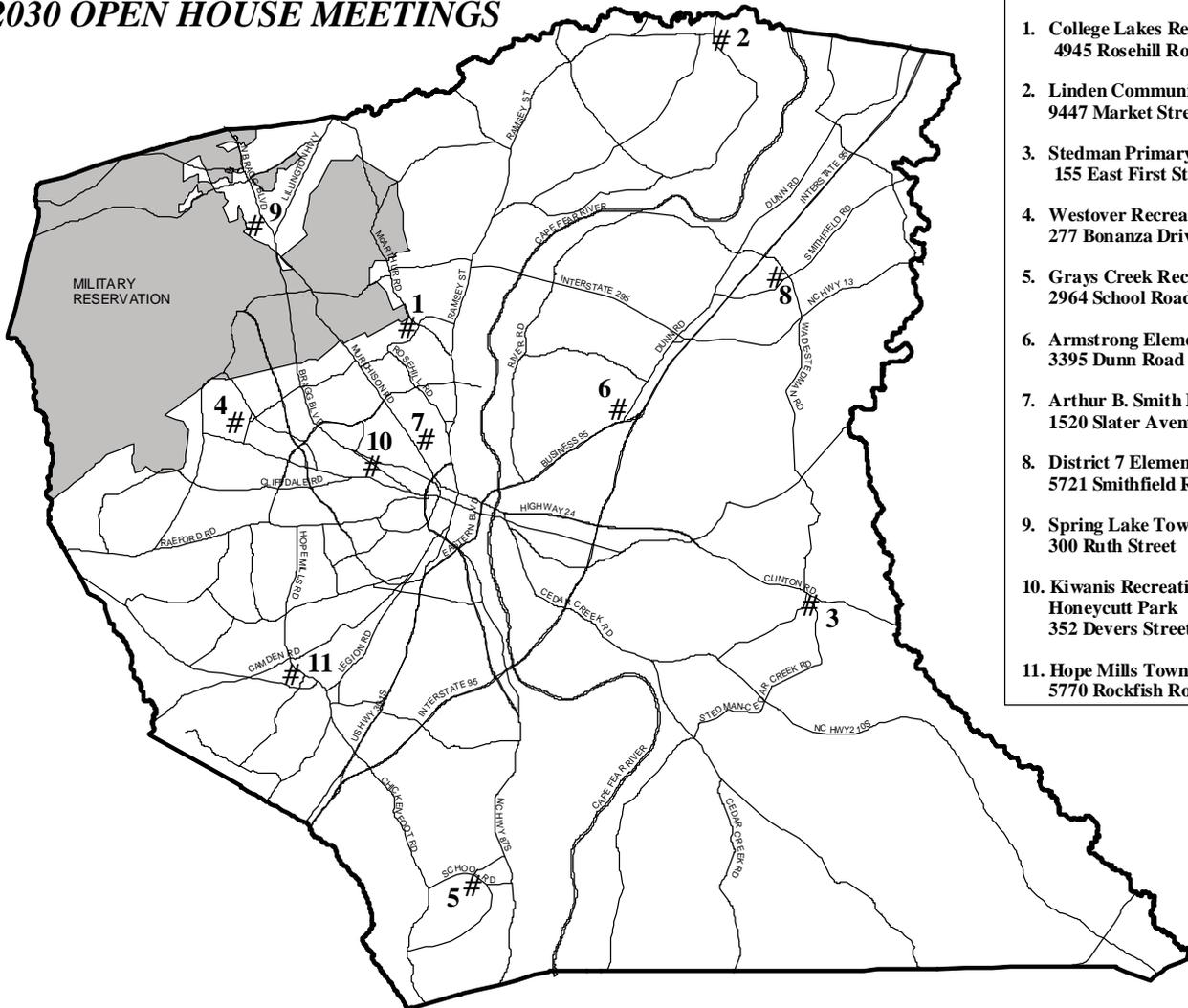

After more than a year of hard work and healthy debate ...

Over the past year, Cumberland County and all of its municipalities have been busy preparing a **Joint Growth Vision Plan**. When adopted, the plan will directly influence decisions about economic development, land use, water and sewer utilities, parks, recreation and open space, transportation improvements, and community appearance-- to name just a few. To lead the effort, a Growth Vision Task Force, made up of elected officials and planning board members from across the county, has been meeting monthly to discuss the concerns that many of us share:

- ☞ **What can be done to improve the appearance and function of our major roadways?**
- ☞ **How can we deliver better government services while keeping local taxes down?**
- ☞ **How can we avoid future problems from poor drainage and flooding?**
- ☞ **How can we continue to grow while preserving valuable farmland and open space?**
- ☞ **What can be done to provide more options for affordable housing?**
- ☞ **What are the best ways to maintain and improve our older neighborhoods?**
- ☞ **Are there changes needed in the way we meet our park and recreation needs?**

Our schedule calls for us to present a Draft Plan to our elected officials later this spring. But before we present any plan for consideration of adoption, we want to hear from you, our fellow citizens, so that we may include your comments and perspectives on the Draft Plan.
